### **VII. Old Business**

#### **A. Web Site Scoring & Stats System**

It was decided that a presentation would be given at our fall meeting regarding the scoring and stats system available for our website.

## **B. Posting of Game Scores & Forfeits**

Discussion was held regarding our rule that league game sheets must be submitted to League Secretaries with 5 days or the game will be a forfeit. Scott Schafer will form and work with a committee to develop a proposal for our fall meeting to address this rule and other problems that have arisen regarding schedules and game sheets.

## **VIII. New Business**

### **A. Player Development Director**

Motion was made by Keith Holland to approve Scott Koberinski as Player Development Director. Motion was seconded and passed.

## **IX. Reports**

### **A. Treasurer**

Treasurer report was accepted.

### **B. Youth Leagues**

Scott Schafer's report was accepted as submitted in writing.

### **C. Girls/Women's League**

Keith Olson reported that there were enough 12U teams for two tournaments this past season. He asked that one District Director from each District serve on a committee with him to handle girl's issues that arise during the season. He reported that everyone was very pleased with the State Tournaments and their host communities.

### **D. High School Boys**

Dennis Moore's report was accepted as submitted in writing. He noted that Watford City and Crosby have swapped hosting the State Tournament for 2011 & 2012. President Evenson thanked Dennis for all his hard work and a great job this past year.

### **E. Registrar**

John Colter's report was accepted as submitted. Mr. Colter also stressed the importance of getting prior approval from him before any of our NDAHA teams play games, scrimmage or practice with any non-USA Hockey registered teams, such as Canadian and high school federation teams. Travel permits are also required for all Canadian games.

### **F. Coach in Chief**

Dave Hoff's report was accepted as submitted. Bob Gillen reported that he is working on a budget for the District and we may need to make some changes in our procedures. He also reported that a new curriculum is being developed that will add age-specific training. A Level 4 Coaching Clinic will be held in Billings, MT August 20-22, 2010 with ND hosting one in 2011. A High School Coaching Symposium will be held November 6-7 for all high school level coaches, NDAHA and federation. Levels 1-3 can be attained at this event.

### **G. Player Development**

Scott Koberinski discussed the direction the new Player Development Executive Committee is taking. They welcome all suggestions and have weekly meetings for discussions.

### **H. Discipline Chair**

Bruce Rostad reported that he would like each District to have a discipline person to work with him to follow-up on any discipline issues and make sure penalties have been served. He asked that team contacts for Canadian and out of state teams be written clearly on the gamesheets. Bruce explained that he has elevated some penalties over the referee's decision and his first concern is always the safety of the participants. He is our liaison with the referees and has communicated his concerns with them. He asked for the communities and the Board to support his decisions and noted that affiliates can also take supplemental disciplinary action. Dave Hoff will keep a database on coaches that have a history of problems.

### **I. Director Emeritus**

Pete Sonnesyn reported that he has been assigned to work with the Dakota Jamboree this fall for Peewees and Bantams.

### **K. President**

President Evenson thanked everyone for a great season. He noted that our District Directors have worked hard to keep things running smoothly in their districts.

President Evenson reported that we sent 4 girls teams and 3 boys teams to the Presidents Cup in South Dakota this spring. We also sent two teams to a National Tournament. The 14U and 16U ND Starz teams had great success at the tournament, with the 14U team losing only one game and the 16U team winning the IIIA level.

The Spring Selects had a late start but we were able to put 358 players through the program. We expect higher numbers next year with the addition of our Player Development Executive Committee. President Evenson thanked Betty Triplett, Scott Schafer and Tammy Fossum for all their assistance this spring.

Team ND, consisting of High School Senior boys, attended the MN Showcase. Five teams participated including Michigan, Wisconsin, North Dakota, and two teams from Minnesota. We are invited back again next year and it was a great opportunity for our players.

Scott Schafer discussed questions that arose from this past season, such as admission fees and the methods of charging. He will work on a proposal for the fall meeting to address these concerns. He stressed that the District Directors have addressed any issues that arose with tournament hosts.

TOURNAMENT OFFICIALS states "See referee handbook for instructions for officials." Scott Schafer moved to discuss this issue. Motion was seconded and passed. Troy Miller moved that we remove this sentence from our Rules and Regulations. Motion was seconded and passed.

### **B. Fall and Winter Board Meetings**

The Fall Board Meeting will be September 25 in Devils Lake. B League scheduling will be held the same day. The Winter Board meeting will be held in Rugby in January 2011 at a date to be determined.

## Coach-in-Chief Report

The coaching section put on Level 1, 2, and 3 clinics in each of the four districts. Sites were Minot, Bismarck, Grand Forks, and Fargo. The clinics were well attended- especially the clinics in Fargo in mid-November. Each of those clinics had between 80 and 100 attendees.

As coach-in-chief I also presented about 8 parent education courses for different affiliates in the state. These courses were free of charge to the affiliates- my mileage was paid from the coaching education budget.

USA Hockey has said that coaching certification will remain the same for 2010-11. In other words, all coaches on the bench, in the locker room, and on the ice must have the proper certification level. There is some talk that in the future USA Hockey will go back to "progressing towards the proper level." If that happens then coaches would only have to take 1 level per year while working towards that correct level of certification.

I have begun to put together video of practices. We have started to use these videos in our coaching education courses. My hope is that coaches will see some of the things we are talking about and be able to go back and duplicate that scenario. These videos promote skill development, goaltender drills, utilizing more players in a practice, etc.

My goal for 2010-11 is for the coaching education section to have more information out there that coaches can access and use.

## High School Hockey League Report

For the 2009-2010 season we started with 9 teams, Crosby, Fargo Flames, Fargo Flyers, Grand Forks Stallions, Langdon, Mayport, Richland, Rugby, and Watford City. Each team had between 12 and 20 players on them. The Fargo Flames were able to recruit enough players to create a second team. With the Fargo Flames Black and the Fargo Flames Gold the league finished with a total of 10 teams.

Splitting players is never easy or without its controversies, but sometimes it is what is best for the kids. Therefore, I would like to thank the Fargo Flames for deciding to create a second team.

Penalties for fighting and games misconducts seemed to come to groups this year, some weeks were good others weren't quite so good. I feel that league rules requiring an additional game suspension for fighting and misconducts have helped.

Teams in the league averaged 7.6 penalties per game this year, compared to 8.8 last year. To put this in perspective, teams in the ND Federation High School league averaged 5.5 penalties per game. When you consider that Federation hockey plays 17 min periods and we play 20 minutes their average should be closer to 6.5 penalties. Our teams average just 1 more penalty per game.

Including the state tournament, each team played at least 21 games. The league doesn't have any restrictions on the number of games that a team can play so many teams pickup additional games. For example, Richland played a 38 game season (18 league games, 3 at the State tournament, 13 at invitational tournaments and 4 at the Presidents Cup at the end of the season).

The league standings were very close this year, 3 points separated the first 3 places and 3 points also separated the 4<sup>th</sup> - 7<sup>th</sup> place. The Grand Forks Stallions finished first with a record of 17 -1. The Fargo Flyers finished second with a record of 16 -2.

The coaches of the league voted for the coach of the year. This year two coaches were chosen, Tony Byzewski of the Grand Forks Stallions and Jay McClintock of the Rugby Ice Hawks. The coaches also nominated and voted on an all-state team consisting of 12 forwards, 6 defense, and 2 goalies. Selected to the team were:

**Forwards:** Finn McCullough - Fargo Flyers, Eric Dennison - Grand Forks, Mitchell Nyhammer - Fargo Flames Black, Adam Haulter - Fargo Flyers, Chris Larsen - Watford City, Jake Srur - Fargo Flyers

Hosting the State tournament is never an easy task, and I would like to thank the Grand Forks Stallions for hosting this year's State Tournament. This year's State Champions were the Fargo Flyers, with the Richland Rangers finishing second.

With Crosby working towards building a new facility, the league has approved Crosby and Watford City switching years for hosting the State Tournament. Watford City will host for 2010-2011 and Crosby for the 2011-2012. (I have been told that they will be keeping the old grill. They will still have their wonderful burgers.)

On the NDAHA website we added a stats option for the High School League. By doing this we were able to generate player and team stats. For each game, the website generated a printable game sheet and a game timeline. For next season we will try to have a home team volunteer update the information shortly after the game is finished.

Overall I feel that the league is doing well and will continue to get better.

## **2010 NDAHA Pee Wee B1 State Tournament Tournament Report**

The 2010 NDAHA Pee Wee B1 State Tournament was held in Williston, ND on March 5-7, 2010 at the Williston Basin Skating Club, Inc. (WBSC) Agri-Sport Complex.

Overall the tournament went very well on and off the ice. On the ice, all games started as scheduled with adequate time for warm-ups before each game. Officiating encouraged fair play and sportsmanship, and the players and coaches acted accordingly. Off-ice officiating and ice resurfacing volunteers did a great job. The loss of wireless communication between scoreboard controller and scoreboard (system less than a year old) caused some panic several times during tournament – disappointing in the fact that the system is less than a year old. Credential checks went well and team officials were very cooperative.

Off the ice, tournament gate fees were kept to a minimum (family weekend pass - \$30.00) and the fans seemed to appreciate the value. Tournament shirts/hoodies, programs and player pictures were available for purchase by players, coaches and fans. Concessions were available during all games. Concession revenue was limited due to the fact that teams played one game per day giving them plenty of time to eat outside of the rink. Other activities such as a skill contest or player/coach socials were not held due to a lack of volunteers. The volunteer numbers would have been greater if Williston had a team playing in the tournament.

The WBSC and community volunteers enjoyed the opportunity to host the tournament and meet hockey players, coaches and fans from across the state. We hope that all involved enjoyed their hockey experience in Williston.
