President Evenson announced the following personnel changes:

**IV. MINUTES**

Motion was made by David Duckworth to approve the Minutes of the Affiliate-Board Meeting of May 1, 2010. Motion was seconded and passed.

## **V. OLD BUSINESS**

### **A. Scoring & Stats System for Website**

Discussion was held regarding using our website to record scores and stats.

Motion was made by Scott Schafer to implement a website scoring system for a one year trial to record the scores for all leagues and the statistics for the Boys High School League. Motion was seconded and passed.

Keith Holland will set up and work with communities to input information.

## **VI. NEW BUSINESS**

### **A. Affiliate/Board Communication**

President Evenson handed out information on chain of authority for Michigan as an example for NDAHA to follow. This information will be posted on our website.

### **B. Committee Assignments**

President Evenson announced that the membership of all committees will be redone and asked for volunteers to serve on these committees. Information will be posted on our website.

### **C. NDAHA Team & Program Marketing**

Keith Holland reviewed a sponsorship advertising draft with the purpose of renewing efforts to promote hockey in ND by increasing awareness and communication, sponsorship and advertising. Options may include arena dasher boards, player development jerseys, NPHL team sponsorship, national team sponsorship, website advertising, state tournament books and state tournament banners. ### **D. USA Hockey Locker Room Procedures**

President Evenson explained USA Hockey's locker room policy and stressed that we expect all affiliates to follow this policy. Anyone monitoring a locker room must have a background check completed. It was suggested to help eliminate any problems to only give players only 15 minutes before and after each practice to be in the locker room. It was also stressed that players should never be alone in the locker room with a coach.

### **E. ADM PRESENTATION BY DAVID HOFF**

President Evenson presented David Hoff with the USA Hockey Young Leader Award and thanked him for all the great work that he does for hockey in North Dakota.

David Hoff presented information on the ADM program. He explained that it is designed for everyone and every community must use the ADM model for their practices. He noted that coaches must change their old methods and try this

new system, which is based on science. USA Hockey's goal is to implement the program for ages 8 and under players this year, with ages 10 and under planned for next year. He is planning ADM meetings in the four districts this year which will be geared toward mite coaches and coaching directors. He is also preparing newsletters to send via email and is available to attend parent meetings.

#### **F. Fargo New or Consolidated Affiliate Discussion**

President Evenson introduced Brian Werk, representing Fargo Youth Hockey. Mr. Werk explained the current affiliate situation in Fargo and issues that have arisen. He asked for the Board's approval for the Fargo Flyers, Fargo Raiders, and Fargo All City affiliates to transition into one new affiliate. Fargo Flames and Fargo Angels would remain independent.

Motion was made by Jay Marshall to approve the transition of Fargo Flyers, Fargo Raiders, and Fargo All City affiliates to transition into one new affiliate conditional on the final approval of NDAHA Board of Directors. Motion was seconded and passed.

#### **G. Discipline Policy Discussion**

President Evenson reviewed a handout from Bruce Rostad regarding discipline procedures. Discussion was held on the penalty for failure to comply and on the need for 30 days to hold any hearings.

#### **H. Fall Scheduling Meeting Update**

#### **I. Other**

Scott Schafer explained that the Fargo Angels have asked to have a team in the Bantam A league.

Motion was made by Scott Schafer to approve the Fargo Angels participation in the Bantam A league with a three-year commitment. Motion was seconded and passed.

### **VII. REPORTS**

#### **A. President**

President Evenson explained USA Hockey's Bylaw 10, Resolutions of Disputes, Arbitration, and Suspension. This is located on page 84 of the Annual Guide and must be followed by all affiliates and NDAHA.

Keith Olson reported that the 19U state tourney needs a host. It will be a 12-team tourney. The 12U state tourney will be hosted by Bottineau and the 14U will be hosted by Grand Forks.

**E. Boys High School League**

Dennis Moore reported that Watford City is planning to host the state tourney and will make a decision in the next few weeks, dependent on motel room availability. There are 8 teams in the league this year. He encouraged all affiliates to put extra effort into ensuring that all players have a team to play on this season, including those who have teams through their high schools.

**F. Player Development**

President Evenson reported that there have been changes in personnel in the Player Development committee. Brad Berry has left to coach in the NHL. Erik Fabian has left to be an assistant coach for the UND girls hockey team. Bob Gillen has moved out of the district. Scott Koberinski reported that district coordinators should be in place next week.
